Medi-Cal Update

- As of January 1, 2024, multiple changes:
 - Still income eligibility of 138% of Federal Poverty Limit (FPL). \$20,782 for single in 2024
 - Asset limitation removed. You can have as much cash in bank accounts, homes, financial resources
 - Immigration status removed. Anyone who can provide an address in CA (utility bill, lease, phone bill) is eligible for Medi-Cal
 - Receiving Medi-Cal does NOT count against public charge determination

TakeMeHome.org

- Free testing program funded through California Department of Public Health (CDPH)
- San Mateo is one of 14 counties participating
- Residents 17 and older can order online at <https://takemehome.org/>
- Can order HIV (oral rapid or fingerstick conventional), HCV, syphilis, gonorrhea, chlamydia tests
- Resident sends in specimens and receives results
- San Mateo Public Health receives positive results in order to follow up with treatment



Edison Clinic Updates

- CDPH is transitioning from ARIES to HIV Care Connect (HCC)
 - ARIES is over 16 years old, needing to switch to newer system
 - HCC will include ADAP and eHARS (HIV surveillance) data, basically combining all HIV data systems
 - All Ryan White and HOPWA funded agencies transitioning
 - Current plan is May 6, 2024
 - Clients will need to sign a new Consent Form
 - HCC will still be a shared system



Edison Clinic Updates

- Edison Clinic is upgrading the Electronic Medical Record (EMR) to EPIC
- This is an upgrade throughout all of San Mateo Medical Center (SMMC), including Dental Clinic
- This combines multiple EMRs that SMMC has used into one system
- EPIC is used by most large medical facilities (Kaiser, Sutter, UCSF, Stanford)



Edison Clinic Updates

- Edison Clinic has begun offering Long-Acting Injectable Anti-Retroviral Therapy (LAI ART); Cabenuva
- LAI ART is a once-monthly injection instead of taking daily oral medication
- Being offered to patients who:
 - Have no resistance to either medication in Cabenuva (cabotegravir and rilpivirine)
 - Are virologically suppressed for at least 6 months
 - Are not pregnant
 - Are not on other medications that have a contraindication
- Currently around 30-40 patients at Edison Clinic receiving LAI ART



Edison Clinic Updates

- Edison Clinic staffing updates:
 - Pharmacist on staff who can:
 - Oversee all PrEP and Cabenuva (LAI ART) treatment
 - Completes medication reconciliation after a hospital discharge
 - Consults for drug resistance and drug-to-drug interactions
 - Helps with prior authorizations for medications not covered by insurance
 - Co-manages diabetes and hypertension with PCP and specialists
 - Social Worker who was providing harm reduction therapy has left, currently in hiring process
 - Adding a temporary Eligibility/Financial Benefits staff to assist with transition to HCC and EPIC



Edison Clinic Updates

- Edison Clinic has begun the annual Client Satisfaction Survey
- Started in February and planning on going until June or July
- Looking at electronic survey system such as Survey Monkey in order for clients to have easier access



Edison Clinic Updates

- Edison Clinic is working with CDPH to provide incentives to HIV+ patients who have not received the mpox vaccine
- Currently identifying patients who have not received any mpox vaccine so outreach and education can be provided to bring in for mpox vaccine
