Cordilleras Update

Presented by Terry Wilcox-Rittgers

### **About the programs that will be housed at the future Cordilleras Behavioral Health Campus:**

The future Cordilleras Behavioral Health campus has been designed to provide a world-class healing therapeutic environment that is far more homelike and far less institutional. This came about from an extensive review of best clinical practices, as well as campus and building models around the world. Treating people in a smaller-scale, more homelike setting reduces social isolation and creates a more natural environment for healing and social skills training, thereby mitigating problems related to adjustment and recovery. There will be four 16-bed mental health rehabilitation centers and co-housing for 57 residents along with a Campus Center. Construction of the new \$155 million campus is currently underway next to the current facility. Completion is slated for the fall of 2023. Learn more about this [project](#).

## Public Comment

Jean Perry

I understand there is a stream running through the property, what has happened in the design to prevent Cordilleras from being under water? My second question, I've heard in the past about truck loads of cigarettes being delivered and I'm wondering if this is going to be an opportunity to make an environment that is healthier regarding smoking?

A: They've re-engineered the entire drain system, so there will be a brand-new sturdy larger piping for all the underground part of the stream. The part of the stream that's been exposed for years is coming out of the woods and into the Cordilleras grounds is still open and has been cleared to make sure it flows properly and not become a flood hazard.

Locked facilities like Cordilleras currently don't have smoking. If a person is not in one of our locked facilities but a resident of the community, they can choose to smoke or not. Persons living there in the suites currently have a designated smoking area.

Chelsea Bonini

Will any of the programming at Cordilleras involve groups other than adults? Are there plans to upgrade the Canyon Oaks facility?

A: Individuals who will be living on the future Cordilleras campus will be adults, they will be at least 18 years of age. Canyon Oaks residents are all adolescents. We have been working with the staff and residents of Canyon Oaks to ensure their needs are addressed as related to the construction process. They are two different programs.

Lisa Mancini

The John Sobrato Foundation will be providing a new basketball court. It's not a new structure but the kids have been playing on this court that isn't safe. We are schedule to meet with our project management with the county to see what we can do upgrade a lot of areas at Canyon Oaks.

Yoko Ng

I really enjoyed learning that Cordilleras residents will be able to collaborate with California Clubhouse. I would really advocate to collaborate with others around self-care and employment programs.
