As a property owner, tenant or person with vested interest in the project vicinity, please be advised that the County of San Mateo Solid Waste Local Enforcement Agency (LEA) has accepted a Solid Waste Facility Permit (SWFP) modification application package from Browning-Ferris Industries of California Inc., regarding the Corinda Los Trancos “Ox Mountain” landfill Half Moon Bay Ca. The LEA is certified by the State of California Department of Resources Recycling and Recovery (CalRecycle) to enforce state laws and regulations at solid waste sites and facilities within the County of San Mateo.

Purpose of This Notification

This notification is for any interested parties to learn more about the proposed permit modification and to provide comments to the LEA regarding this proposed action. As required by Statute, the decision to approve or deny the SWFP modification, will be made by the LEA within 120 days of the date the application was accepted for filing and deemed complete and correct. The proposed modified permit will be submitted to CalRecycle for concurrence prior to issuance of the SWFP.

Description of the Project

On July 29, 2016 the LEA received an application package from Browning-Ferris Industries of California Inc., for the Corinda Los Trancos “Ox Mountain” landfill located at 12310 San Mateo Rd Half Moon Bay CA 94019. The purpose of the application package is to update the existing SWFP to provide a more accurate description of the existing facility and operation. There will be three changes to the SWFP and of the three; none are physical or operational changes to the landfill. The changes are:

- 1) Design Capacity. The design capacity on the existing SWFP will be changed to 69 Million Cubic Yards (MCY) in order to provide a more accurate design capacity to account for the landfill’s current in-place waste and the remaining air space capacity.
- 2) SWFP Section 14. Prohibitions subsection (c) accepting dead animals will be deleted. This prohibition is outdated and prevents the operator from additional needed service to the surrounding community which is primarily agricultural. In addition, accepting dead animals is allowed per CCR Title 27 Section 20890 (dead animals).
- 3) SWFP Section 17 subsection (a) the term RDSI Report of Disposal Site Information will be changed to the current term of Joint Technical Document (JTD) which is the main supporting operational document to the SWFP.

Findings

The LEA has determined that:

- 1.) The proposed changes are consistent with state minimum standards (SMS) for landfill operations. The landfill continues to operate to meet and exceed SMS.
- 2.) The proposed Change is not in conflict with the terms and conditions of the SWFP and is not in conflict with the day to day operation of the facility.
- 3.) The proposed change is consistent with existing CEQA documentations regarding the facility.
