# San Mateo County DRIVING UNDER THE INFLUENCE (DUI) July 2014

San Mateo County has 5-licensed DUI programs that provide first and/or multiple offender program services throughout San Mateo County. These programs are designed to enable participants to consider attitudes and behavior, support positive lifestyle changes, and reduce or eliminate the use of alcohol and/or drugs.

Once convicted of a DUI Offense, individuals will be mandated to complete one of the following programs based on the offense:

# Wet and Reckless (WRP)~ (BAC .08 or lower)

- 12 hours of education only.

# First Offender Program (FOP)~ 3 months (BAC .08 or higher)

- 12 hours of education
- 10 hours of group counseling
- 8 additional hours of program services (education, group or combination)
- 3 face-to-faces

# First Offender Program (FOP)~ 6 months (BAC .08 or higher)

- 12 hours of education
- 28 hours of group counseling
- 4 face-to-faces
- 4 additional hours of program services

This program is slowly phasing out. It was replaced with the 9 month program.

## First Offender Program (FOP)~ 9 months (BAC .20 or higher)

- 12 hours of education
- 44 hours of group
- 4 additional hours of program services
- 4 face-to-faces

## Multiple Offender Program (MOP)~ 18 month

First 12 months: core program

- 12 hours of education
- 52 hours of group counseling
- 1 face-to-face every other week (24 minimum)
- Last 6 months: re-entry phase
- six hours of monitoring (one hour each month)
- participation in self-help groups, employment seeking and other areas of self-improvement

## Services Offered:

**Face-to-face**: monitoring of fees and payments, discuss and encourage participation and attendance, discuss barriers to program completion, evaluate participant's needs for ancillary services.

# San Mateo County DRIVING UNDER THE INFLUENCE (DUI) July 2014

**Education:** lectures, seminars, films, audio, tapes, written exercises, effects of AOD, nature of addiction, impairment of driving abilities, skills and judgment, alternatives to using such as abstinence, self help groups, ancillary services, effects on family.

**Groups:** process groups, share thoughts, ideas and information for identification and resolve of AOD problems, examine own personal attitude and behavior, positive support for changes in lifestyle to reduce/eliminate AOD use.
