- Medication Support Services have been updated and simplified. Codes 99212CA-99215CA may now be used for Outpatient services provided at any location, including, but not limited to, home, office, phone, telehealth (video). Codes 99347CA- 99350CA have been retired and will not be used moving forward.
- A new category of Case Conference Codes has been added.
