DIRECTOR'S REPORT

Serenity House The renovations for Serenity House continue.

Cordilleras

The renovations for Cordilleras continue to move forward. We are still hopeful that we will go to the Board of Supervisors (BOS) relatively soon to request approval for the actual construction.

Affordable Care Act (ACA)

The good news is that the replacement for ACA never went to a vote. There was talk that there would be a return for a vote, I just read that it is unlikely not to happen.

Budget

The county budget process is moving forward. The June hearings have been scheduled, we are in the final stages of preparing our budgets.

Drug Medi-Cal

The Drug Medi-Cal implementation is moving ahead. We are still working with some of our providers to finalize our contracts and budgets. We hope to have all of our providers on board by the end of the fiscal year.

Housing

The MHSARC spent time on the issue of housing and developed a report for the BOS. There are a lot of different conversations happening around housing (it's complicated and expensive). We have on going conversations with the Department of Housing. Karen Krahn and I had a meeting this week with the representatives from the Health Plan of San Mateo (HPSM) to discuss, as part of our whole person care, how we might be able to create more housing opportunities and supports for people. There's a lot of conversation between the County Manager's Office (CMO), Sheriff's Department, Correctional Health, and Behavioral Health and Recovery Services (BHRS) about our in-custody mental health pods. There's strong support right now and we anticipate that we'll be in a position to significantly expand the number of people being assigned to the pods. Part of it is physical construction issues that create limitations. Currently there are 8 to 10 women in their mental health pods and about 8 men. We are waiting for some minor renovations and then we think we can increase the men's to 13 or 14 but the real goal is to create about 40 beds for men and more for women.

There's a lot of support right now and we will be working on developing a proposal for the CMO on how to establish within the jail an acute psychiatric unit. To create a 10 bed psychiatric unit in custody that would be designated as a LPS facility. People in jail could be voluntarily hospitalized if needed or someone could write a 5150 and hospitalize them. We hope to have the proposal to the CMO as part of the budget process.
