# YOUTH COMMISSIONERS REPORT

### **DIRECTOR'S REPORT**

Outreach – The Parent Project through the Health Ambassador Program really is a very effective outreach program. Essentially we have people who are living in the communities reaching out to other family members telling them about their experiences and having the information to make a good suggestion and/or referral.

### Youth Mental Health First Aid

Our Office of Diversity and Equity Staff are working with the County Office of Education school districts to train school personnel and are starting to train peers around the youth mental health first aid model which is an evidenced based practice. Our goal is to eventually have trained people at every middle school and high school both public and

private. The team just reached a great milestone and they have trained 1,000 people around the county.

### Serenity House

Serenity House is our crisis residential facility that will be located on the corner of 37<sup>th</sup> Avenue and Hacienda in San Mateo. We are making great progress with our renovation. It will be a 10 bed short stay facility. We will have psychiatry, case managers, peer and family members as part of the treatment team. We are hoping to open the summer of 2016.

### Medicated Assisted Treatment Program

Our Medicated Assisted Treatment Program (MAT) is up and running and doing well. We've received close to 120 referrals for the program. Everything is in place with the exception of the clinic to be operated by HealthRight360. They will open a clinic in San Mateo, we are waiting for state approval.

### Recent Events

We recently had two very successful events:

- 1. Suicide Prevention Partnership Meeting, there were 120 in attendance.
- 2. Coastside Health Fair called Sana Sana, there was great community participation.

### Conference

I attended a conference on criminal justice and behavioral health and I had a client from Service Connect accompany me to the conference. His name is Lorenzo and he told his story to the audience of county and contract providers.

I asked him at the end of his presentation to give three pieces of advice to this group to help ensure that people like him are successful when they return to the community. Here is what he told the group:

- 1. Respect. Let's respect each other.
- 2. Empathic detachment. Don't take things personal. We mess up, we relapse, but when we come back don't take it personal, just accept us coming back and we'll engage with you.
- 3. Do your jobs.
