# Program Presentation

Mental Health Services Act Annual Update Presented by Doris Estremera, MHSA Coordinator Behavioral Health and Recovery Services

Background

- Proposition 63 (2004)
  - o 1/5 tax on personal income in excess of \$1 million
- Principles
  - o Focus on wellness, recovery and resilience
  - o Cultural and linguistic competency
  - Consumer/client and family-driven services
  - o Integrated service experience
  - Community collaboration

**Funding Components** 

- Community Service and Supports (CSS), 75-80%
- Prevention and Early Intervention (PEI), 15-20%
- Innovations (INN), 5%, 3 years
- Workforce Education and Training (WET), one time funding
- Capital Facilities and Information Technology (CF/IT), One time funding
- Housing, One time funding

**Fiscal Considerations** 

- AB100, on July 1, 2012, monthly MHSA allocations based on actual accrual of tax revenue
- One time allocations due to change in tax laws in FY 13-14 and FY 14-15
- PEI revenue projected to decrease in 15-16 by 10%
- Prudent reserve remains at \$600K

New Programs/Updates for FY 15-16

- New PEI and INN guidelines
- Continues evaluation efforts of funded programs
- CalMHSA sustainability of statewide PEI
- Priority expansions
  - o The Clubhouse 2015
- Innovations

Full Service Partnership (FSP) Evaluation Presented by Scott Gruendl, Assistant Director Behavioral Health and Recovery Services

Background

- BHRS contracts with American Institutes for Research (AIR) for evaluation services of various programs including the MHSA FSP
- AIR was charged with evaluating how enrollment in the FSP benefits the County's FSP clients
- Parameters included evaluating the FSP over the life of the program (07/01/2006-07/01/2015)
- Two indicators were selected for measuring the effectiveness of the FSP program

Indicators of Well-Being

- Reductions in use of psychiatric hospitals and PES can indicate improvement of mental health status and less need for intensive care
- Two primary sources of data for these indicators:
  - Client self-reports
  - o Administrative data collected through health records
- Administrative data consistently capture utilization with bias from inaccurate or incomplete reporting
- Evaluation used administrative data from the BHRS Avatar System/Electronic Health Record

Outcome Areas

- Evaluation focused on four areas:
  - o Proportion of clients with any hospitalization
  - o Mean hospital days per client
  - Proportion of clients using any PES
  - Mean PES admissions per client
- Results presented in two ways
  - Stratified by tenure in FSP
    - o Stratified by the calendar year clients entered into FSP

#### Outcomes

- The proportion of FSP clients with any hospitalization decreased significantly after FSP enrollment as compared to before enrollment
- The proportion of FSP clients with any PES use decreased significantly after enrollment in FSP from 12 percentage points for clients enrolled one year or more to 17 percentage points for clients enrolled five years or more.

#### Conclusion

Tenure in FSP significantly reduces intensive care utilization; and the impact on positive outcomes by the FSP program has improved over time.
