    - a. Accomplished everything mentioned in last month's meeting minutes
    - b. Operation Life Saver
    - c. Safe Routes to School
    - d. 19 fatalities on Caltrain tracks in 2015 (8 suicides; 1 accident)
  - 2. November is National Suicide Survivor's Month (Vic)
    - a. Local events which include many who have lossed a loved one
    - b. There is an event on the Saturday before Thanksgiving in Santa Clara and San Francisco
  - 3. Focus Group (Vic)
    - a. Conducted with individuals with highest risk for suicide middle aged white males
    - b. Fewest programs for middle aged white males
    - c. There was a control and case group
    - d. Next steps for action include radio ads for sports talk stations and other Bay Area radio stations
  - 4. Crisis Center Data (Vic)
    - a. Vic is looking at trends of crisis center data from various counties in the San Francisco Bay Area
    - b. At a national level, there was a spike in calls after Robin Williams death
    - c. At the local Bay Area level, Vic didn't see the same trends he saw at the national level
  - 5. ASSIST Training (Katy)
    - a. ASSIST training
    - b. 2-day
    - c. Designed for community

- c. Overall, the event was well received (especially the panel) and an area of improvement would be to provide attendees information on next steps and how to get involved with suicide prevention efforts

  - iii. Activity Chart entails existing work and what needs to happen; basis/road map for what committee will work on

  - ii. Katy suggested focusing on building things we are already working on
- c. <u>Suicide Prevention Policy in Schools</u>
  - i. Sylvia suggested presented suicide prevention policy as something this committee could focus on
  - ii. Narges highlighted the need to include elementary schools since there is increasing need to help elementary school students with suicide ideation
- d. Comprehensive Suicide Prevention Toolkit
  - i. Vic shared that their our comprehensive suicide prevention tool kits from SAHMSA and American Foundation for Suicide Prevention
  - ii. These tool kits may tailor to elementary schools
  - iii. Santa Clara County is working on updating its tool kit
  - iv. CA School Board Association has a canned policy
- e. Training
  - i. Katy mentioned that to supplement policy, we also need trainings
  - ii. Know how to implement policy
  - iii. Trauma informed
  - iv. Erika talked about education, outreach for officers and training on page 3 of the Activity Chart
- f. <u>5150</u>
  - i. Some organizations have internal evaluators but, if a person is not willing a police officer or ambulance is called
  - ii. If an ambulance is called, the patient has to pay for it
  - iii. If a police officer is called, officers often handcuff the individual
    - 1. Is a standard to handcuff 5150 individuals but is not law
    - 2. It is done due to liability issues
  - iv. CRISIS Collaborative (which was run by Mary Taylor Fullerton and will be run by Molly Hendricks) is a good space to talk about these 5150 issues
