

Underground Storage Tank Fee Schedule and Application Requirements

Effective 8/01/2017 - 7/31/2018

Approved permits are for 210 days. When the permit expires, new permit fees are required. The district inspector must be notified of any delays or changes to the permit application. Note: Contractors and sub-contractors are required to submit copies of: (1) Contractors license, (2) ICC certifications, (3) Workers Comp, and (4) Hazards Materials Certification.

1. INSTALLATION: New Tanks and Piping, Re-piping and Cathodic Protection.

Fees: **\$ 3,320.00**

Required documents, in addition to above:

- UST Facility Page (formerly Form A)
- UST Tank Page(s) (formerly Form B). One Tank Page for each tank being installed), and UST Form C
- "Permit Application to Construct/Replace/Modify Underground Storage Tank System"
- Four sets of prints and plan check referral sheet. <u>Note:</u> **Re-piping** requires "UNDERGROUND STORAGE TANK SYSTEM CLOSURE PERMIT APPLICATION" packet for the old pipe. No additional removal fee required.
- 2. **REMOVAL**: Removal of Tanks and piping, or piping only (without installation)

Agriculture or Home Heating Oil Tanks <1,100 gallons:

Fees: \$ 755.00, plus \$ 453.00 for each additional tank. No State Surcharge

All Other Tanks:

Fees: Tank and Piping \$2,117.00 for first tank, plus \$453 for each additional tank

Fees: Piping Only: **\$793.00** (compliance samples required). Includes removal of existing pipe with no replacement. Required documents, in additional to above:

- UST Facility Page and UST-Tank Page(s) (One Tank Page for each tank being removed)
- "UNDERGROUND STORAGE TANK SYSTEM CLOSURE PERMIT APPLICATION" packet

3. INSTALLATION: UDC / MONITORING SYSTEM UPGRADE / PIPING REPAIRS (< 18') / TANK RELINING:

Fees: = \$ 1,510.00

Required documents, in additional to above :

- UST Facility Form, UST Tank Page, and UST Form C.
- "APPLICATION FOR PERMIT TO CONSTRUCT/REPLACE/MODIFY UNDERGROUND TANK SYSTEM"
- For UDC, drawings, adequate. Note: may submit blueprints and compliance samples required.

4. MONITORING SYSTEM MODIFICATIONS/MONITORING PANEL CONVERSIONS:

Fees: = \$ 793.00

Required documents:

- "APPLICATION FOR PERMIT TO CONSTRUCT/REPLACE/MODIFY UNDERGROUND TANK SYSTEM"
- Submit cut-sheets and one copy of site map or construction prints.

5. MINOR REPAIRS: Includes: Spill-Bucket Replacement, Sump Repairs, and Misc. Repairs.

Fees: **\$793.00**

Required documents:

"APPLICATION FOR PERMIT TO CONSTRUCT/REPLACE/MODIFY UNDERGROUND TANK SYSTEM"
Submit cut-sheets and one copy of site map or construction prints

6. TESTS / TEMPORARY CLOSURE / CLOSURE-IN-PLACE:

Fees: \$793.00

Required documents:

- 5 year tank interior assessments and tests: Work-plan, site safety plan, and copy of specialized testing license.
- Temporary Closure: Application to temporary close. Boring required after 1 year.
- Closure-in-place: Application to "Close-In-Place" and Engineers Report with Explanation.
