- 1. Call to Order, Welcome & Introductions**
Michale called the meeting to order. **Welcome all! Thank you for coming!**
- 2. Review & Approval of today's meeting agenda**
Today's agenda was approved by consensus.
- 3. Review & Approval of Minutes**
The Board Meeting minutes for July 13, 2016, were approved by consensus.
- 4. Youth Commission Update**
The Youth Commission did not have their mixer in August, where boards and commissions have an opportunity to present to the new commissioners. Matt will follow-up with Youth Leadership Institute on any placement for the year. The group reiterated the importance of having a youth voice for the community board.
- 5. HIV Prevention Update**
Darryl discussed latest Prevention efforts and discussed new PrEP outreach protocols. The Prevention team will be offering PrEP referrals to all high-risk clients. The Prevention team will also contact all MSM rectal gonorrhea cases identified through STD Surveillance in order to offer PrEP referrals. Darryl discussed AB 2640, which was signed by Governor Brown on 9/26/16. This new law requires any medical provider or person administering an HIV test to provide information regarding PEP and PrEP to high-risk individuals whose result is negative.
- 6. Update on San Francisco EMA HIV Community Planning Council**
Matt provided the annual county presentation that he presented to the SF EMA HIV Community Planning Council on 9/26/16. Of note is the continued decrease in newly identified HIV infections for 2015; 47 in 2014 to 40 in 2015. The
