eless Communications System for San	Mateo County is a county-wide UHF "

The Wireless Communications System for San Mateo County is a county-wide UHF "T-Band" radio system that provides narrow band digital trunking and wide band analog conventional operation with mobile radios, portable radios and control stations. Each user of the system has their own "Talk Groups" assigned to their agency. In addition, all agencies have a series of "County Common" and "System Common" Talk Groups that allows for communication amongst the various system users.

All radio traffic shall be conducted in strict accordance with FCC regulations and County policies. Unprofessional conduct and/or comments on any EMS radio channel are strictly prohibited.

 - 1.1 Dispatching calls for service
 - 1.2 Tracking of units on calls for service
 - 1.3 Dispatching of post assignments

- 2. Hospital Talk Groups (Zone A) Usage
 - 2.1 Principal communication Talk Groups between field units and each receiving hospital. The Talk Groups are as follows:
 - 4.5.7 Peninsula= PEN
 - 4.5.8 Stanford=STAN
 - 4.5.9 Seton=SETON
 - 4.5.10 Kaiser Redwood City=KSRRWC
 - 4.5.11 San Mateo Medical Center=SMHC

- 3. Tactical Talk Groups are for utilization by EMS Units for communication between vehicles and personnel for the purposes of medical supervision and instruction for treatment and transport of patients. The tactical Talk Groups available to the EMS units are:
 - 3.1 YELLOW (Zone A): Trunked Talk Group that is used for unit to unit communications.
 - 4.5 Simplex (Soft Key) Non-trunked Talk Group used for unit to unit communications outside the trunked system coverage area.
 - 4.6 County Commons 1-4 (Zone B)Talk Groups programmed to communicate with other San Mateo County specific departments or agencies that use the trunked radio system.

- 3.4 System Commons 1-4 (Zone B) Talk Groups programmed to communicate with all trunked Radio system users within San Mateo County including cities, special districts etc.
- 3.5 MCI 1 & MCI 2 (Zone C): Talk Groups dedicated for the coordination of medical resources during a multi-casualty incident (MCI).
