SERVICE	ANTICIPATED RELEASE DATE	DESCRIPTION
LGBTQ Coordinated Service Center	Released on 7/20/2016	The purpose of this RFP is to develop a center that will provide a place for a wide range of services for LGBTQ individuals at high risk for SMI/SED related issues. The LGBTQ Center will be operated through a collaboration of multiple agencies that have demonstrated knowledge and expertise serving this population. This is a new service.
Crisis Response In-Home/TBS	TBD in November 2016	Immediate treatment alternative to out-of-home placement for youth who are recently released from Juvenile Hall, at risk for group home placement, not a danger to themselves or others, and who are in need of additional support to stabilize and transition into the community.
Full Service Partnership - Youth	Requesting waiver for 2 years	Assist highest risk children and youth with Serious Emotional Disorders (SED) to remain in the community, with their families or caregivers, while attending school and reducing involvement in juvenile justice and child welfare. Program will reflect core values of Wraparound.
Research & Evaluation	Waive 6 months to put back on fiscal year schedule	The purpose of this RFP is to solicit proposals for the provision of research and evaluation services to assist the Behavioral Health and Recovery Services Division (BHRS) to evaluate services and conduct data analysis for system improvement.

SERVICE	ANTICIPATED RELEASE DATE	DESCRIPTION
Full Service Partnership – Adult	Requesting a one year waiver	Two services are offered within the RFP: Integrated/Embedded FSP services and Comprehensive FSP services. Integrated/embedded FSP services will be provided in partnership with County operated service locations, and will serve clients with complex and co-occurring illnesses that complicate their mental health treatment. Comprehensive FSP services are 24 hours a day, seven days a week to adult clients who are in need of multi-agency community supports to divert from incarceration, or to clients in locked mental health facilities who can succeed in the community with intensive supports. Comprehensive FSP also services older adults who are seriously mentally ill and medically fragile and may be at risk of institutionalization.
Peer-led support services through a recovery community organization	Requesting 2 year waiver	The purpose of this RFP is to identify a peer-led recovery organization that will provide opportunities for education, wellness and support services for individuals in (or in need of) long term recovery from substance abuse, and support services for impacted families.
Peer Support/Self Help – Mental Health	Requesting Letters of Interest in FY 16-17	The purpose of this RFP is to identify a peer-led support/self-help organization that will provide recovery-oriented services for adults living with a serious mental illness as well as those consumers with co-occurring substance use disorders. Services shall include, but are not limited to stigma reducing education, wellness groups, and other support activities.
PREP Services	Requesting a waiver in FY 16-17	“Prevention and Recovery in Early Psychosis” (PREP) services aim at achieving remission through early detection, meticulous diagnosis and an array of evidence-based treatments. PREP services the client and/or family where they are most comfortable receiving those services, and employs peer providers to reach-out to clients and families to create and sustain a connection with the program.

BEAM Services	Requesting a waiver in FY 16-17	The Bipolar Early Assessment and Management (BEAM) model uses a diagnosis and assessment process that is both rigorous and comprehensive, for the early detection and treatment of symptoms and addresses both bipolar disorder and other co-morbid mental health or substance abuse issues.
AOD Prevention Services	Requesting a waiver in FY 16-17	This RFP is based on a Strategic Prevention Framework (SPF) plan to create a sustainable, community-based prevention focused infrastructure that will build partnerships between local government agencies, schools, faith-based organizations, law enforcement, community-based organizations, businesses and residents. Components of the SPF are: assessment, capacity building, planning, implementation, and evaluation.
AOD Treatment Services	Requesting a waiver in FY 16-17	The purpose of this RFP is to provide a continuum of substance use disorder treatment and recovery services. Services are client-centered, recovery focused, and based on evidence-based or promising practice models and culturally responsive to the characteristics and needs of individuals seeking care. Modalities included are: Adult Day Treatment and Outpatient Services, Perinatal Day Treatment and Outpatient Services, and Adolescent Outpatient Services.
Laboratory Services	TBD in FY 16-17	The purpose of this RFP is to provide clinical laboratory services to BHRS and Correctional Health clients of the San Mateo County Health System. Services shall include, but not be limited to, the following: chemistry, drug testing, hematology, pap smears, and blood counts associated with Clozapine and Clozaril groups.
