YTD: Year to Date. <sup>1</sup>Early Syphilis is defined as primary, secondary, and early latent <sup>2</sup>Cases not included in the total as neurosyphilis is a sequelae and not a stage; the neurosyphilis cases are captured under other syphilis stages.

- CT increased 20% in men and 6% in women compared to this time last year.
- GC cases increased 26% in men and 30% in females compared to this time last year.
- Early syphilis cases increased 14% (almost all cases in men) compared to this time last year. To date in 2017, there were 29 female (6 early syphilis cases and 23 late latent) syphilis cases.
- Health system HIV positive prevalence was 0.6% in 2017, an increase from 2016 (0.5%). HIV cases identified at county clinics increased in 2017 (0.6%) compared to 0.5% in 2016.

## Increasing Capacity for STD screening in San Mateo Medical Center (SMMC) Primary Care Clinics



- In 2018, the SMC STD/HIV Program will work with SMMC Primary Care Clinic Medical Directors and Staff to increase STD screening and testing capacity in their clinics.
- Chlamydia and gonorrhea self collection by men who have sex with men (MSM) patients at rectum and throat will be piloted in 2018 at the SMMC lab on main campus.
- We encourage all SMC Primary Care providers to screen for STDs based on CDC recommendations www.cdc.gov/std
- We encourage Primary Care providers throughout the county to conduct STD screening based on CDC recommendations.
