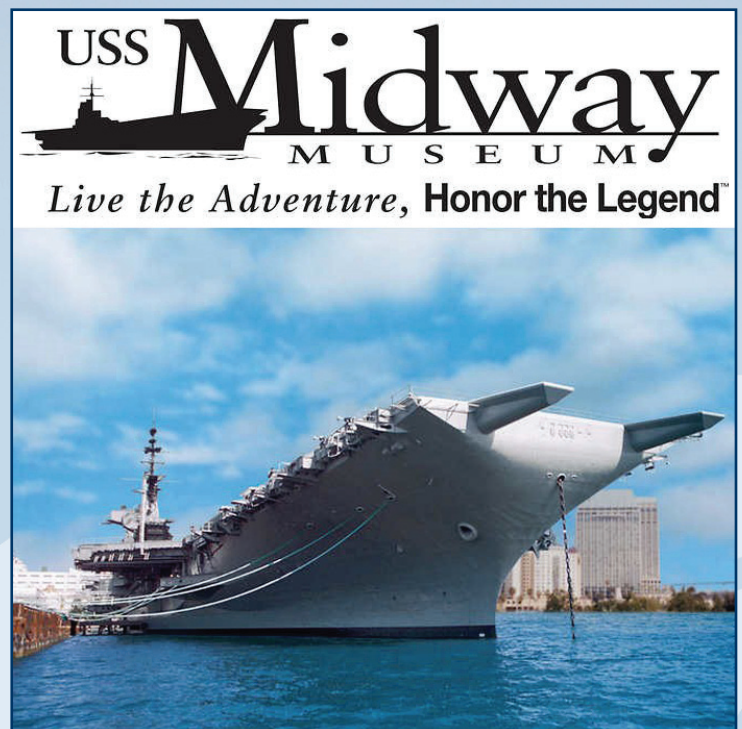
OPTIONAL MIDWAY TOUR

Keynote Speakers



Kevin Hazzard – Kevin Hazzard worked as a paramedic from 2004 to 2013, primarily at Grady Hospital in Atlanta. His freelance journalism has appeared in Atlanta Magazine, Marietta Daily Journal, Creative Loafing, and Paste. He is the author of a novel, *Sleeping Dogs*, and *A Thousand Naked Strangers*. He and his family live in Hermosa Beach, California. In the aftermath of 9/11 Kevin Hazzard felt that something was missing from his life—his days were too safe, too routine. A failed salesman turned local reporter, he wanted to test himself, see how he might respond to pressure and danger. He signed up for emergency medical training and became, at age twenty-six, a newly minted EMT running calls in the worst sections of Atlanta. His life entered a different realm—one of blood, violence, and amazing grace. Regarding his 2016 memoir, *A Thousand Naked Strangers*,

Pat Conroy, New York Times bestselling author writes:

“A shocking, utterly compelling tour de force that shows the dark heart of an Atlanta that I never knew existed...Hazzard writes in an elegant, low-key style, racing from crimes scenes to fatal accidents to the birthing of babies. I couldn’t let the book go – it’s powerful enough to have turned me into an ambulance chaser in my own small South Carolina town, but it’s also very, very funny.”



Daniel Patterson – Dr. P. Daniel Patterson studies safety in emergency care settings with special emphasis on safety culture, fatigue, shift work, sleep health, teamwork, medical errors and adverse events, and clinician injury in the prehospital EMS setting. Collaborations have led to creation of reliable and valid safety measurement tools and establishing base rate data for key indicators of EMS safety. Dr. Patterson has led multi-disciplinary teams in evidence reviews and experimental studies testing novel interventions to improve safety. His research is informed by immersion in the EMS setting as a paramedic clinician.



Staff Sergeant Emmett Spraktes – Staff Sergeant (SSG) Emmett Spraktes is the author of “Selfish Prayer,” which chronicles his experiences and the service of his fellow unit members in the killing fields of Afghanistan. He served for 10 years in the US Navy Reserve and then enlisted in the California Army National Guard and volunteered to serve as a ground medic to Iraq and on tour in Afghanistan he evacuated/treated 184 patients, flew 250 combat flight hours and participated in 12 individual hoists. SSG Spraktes is the recipient of numerous medals and awards, including an Army Aviation Association of America Award for Medic of the Year and Rescue of the Year. He is a graduate of Flight Medic course and numerous other military courses. SSG Spraktes Honorably retired after 20 years of military service and 25 years of law enforcement, which included service in the

California Department of Corrections, The California State Police, Vacaville Police Department, and the CHP. Spraktes is currently a Nationally Registered Paramedic (NREMT-P) and California State licensed paramedic and is an associate academy instructor for the California Highway Patrol Emergency Medical Services Unit. Spraktes has been interviewed by numerous radio talk show hosts and has lectured as a featured presenter and keynote speaker for a variety of organizations and Law Enforcement Associations. He continues to teach Tactical Emergency Medicine (TEMS) to military and law enforcement organizations on tactical pre-hospital medicine and techniques, such as patient movement under fire.
