	Transportation committee discussed the addition of transportation via SamTrans for people seeking rides to vaccination clinics. This is only for walk-in clinics. They also discussed the ongoing search of the Paratransit Coordinating Council for more members. Committee has assisted in outreaching to the public.
	The Age Friendly Ad Hoc Committee is compiling data from calls and meetings being held with othe Counties to assess how Age Friendly work is supported.
7. May Older Americans Month	Discussion took place regarding the annual presentation to the BoS in recognition of May as Older Americans Month. Discussion also included suggestions for acknowledging service providers for their work.
