Review of CoD Work Plan Goals Related to Accessible Transportation Future potential work plan objectives, which will be shared at the Board of Supervisor's meeting in October. 5 Paratransit Partnership County Center accessible drop-off location clarity is underway Partnership with Paratransit Advisory Council Updates on 101 Accessibility ADA compliance committee will likely meet again in August if June meeting not rescheduled – no updates at this time **Emergency Preparedness pamphlets** CoD provided a letter to the Department of Emergency Services. There has been no update regarding their existing plans for supporting people with disabilities during a disaster/emergency. Tim will follow up. Committee would like to develop materials to share at outreach events regarding emergency resources for disabled people, similar to materials developed by the Commission on Aging. Travel Training, "Mobility Ambassador" program Lynn shared that SamTrans has an ambassador travel training program, coordinated by Margaret Baggerly SamTrans has contracts with organizations serving disabled people to conduct this training, such as with Vista Center for the Blind. Tim asked about BART training: Lynn noted it is not part of training since it primarily does not serve San Mateo County. Other Business 6 • Lynn shared maps of SamTrans/paratransit considerations for disabled access to County Center and the Manzanita room for Commission and other government meetings. SamTrans inspectors have conducted field observations and determined their preferred location, on the Winslow side of County Center: It is already a wide-curb cutout, clearly marked, and designated for passenger loading/unloading. Also used for County Center deliveries and use by non-paratransit will need to be monitored. A second option, but far less preferred by SamTrans, is on Middlefield, closer to Manzanita room. It is not preferred to due large and busy intersection, lack of safety, and obstacles nearby including a tree, red curbing, frequent need to double-park, and traffic congestion. o SamTrans' evaluation does not recommend pickup and drop off on

Marshall due to safety concerns.

Lisa asked about paratransit's ability to drop-off in the jury lot. Due

- to vehicle height, it is not possible.
- Mathew motioned to recommend to the CoD Executive Committee to bring forward to the General Commission a proposal to support the SamTrans recommendation to locate the paratransit drop off on Winslow. Lisa seconded, unanimous approval.
- Reminder that all Commissioners will be attending the Inclusion Festival in July.
