Her role is to facilitate the process of getting input from the committee on which projects from the transition plan to apply for funding through the county's Capital Improvement Projects Budget (CIP). The committee goes through all the buildings that are identified and determines what are the most important improvement projects to put forth on the Capital Improvement Project list.
