I attended the Nami California National Conference last week. It was 2-day conference in Sacramento, it was that was very interesting. I also wanted to remind everybody that the California Association of Local Behavioral Health website has a great website on boards and commissions. It's an excellent resource for information on the roles and responsibilities of commissions and commissioners and best practices.

Patrice Massicotte, Heart & Soul

Heart & Soul has been running Alternatives to Suicide Peer Support Groups since March. This is a fully peer support group. It's a safe space non-clinical where individuals (for now it's adults), who are having suicidal thoughts or are suicide attempt survivors like me, we can come together, discuss and share our thoughts in a safe space. We run it twice a month, the first Thursday and the third Thursday in person at Heart & Soul. We are expanding the groups. In October we'll have: Youth Alternatives to Suicide, Young Adult Alternatives to Suicide, and Family Member Alternatives to Suicide. The family member group is for family members who live with a loved one who has suicidal thoughts or is a survivor.

John Butler, Health Ambassador with the Office of Diversity Equity (ODE) and I work with NAMI (National Alliance on Mental Illness) San Mateo.

Supervisor Corzo has graciously agreed to speak for us at an open mic event and that will be either on Friday, September 22, or Friday, September 29. We are working on several events, we have support from Heart & Soul, Voices of Recovery Services and possibly California Clubhouse. There's another event developing with the ministry that I'm a part with mental health first aid instructors. Kingdom Love will speak, she's done a lot of work with churches, Catholic churches as well, and I'm excited to say that this is in progress. Stay tuned.

- Our Chief of Police on this commission knows that I call the embedded clinician program that she runs "Cwacrit" because how else would you pronounce CWCRT. I bring that up because, when I use the word "Smucker", you'll know that I mean SMMCR.
- 2. The RFP appears to be written for or by Star Vista. How do we know?
  - a. Page 18, section D: The contracted agency, working with BHRS and the County-contracted Crisis Services Hotline (650-579-0350), shall establish a system including policies and procedures for dispatching mobile crisis teams. This phone number is that of Star Vista.
  - b. They still don't get that the calls need to be 911. Joan and John Q public are going to call 911 when they fear anyone they don't know, who has mental health crisis, or they see someone screaming about being attacked by space aliens or locked in the restroom of a restaurant and refusing to come out. They'll not be calling 988. They'll not be calling Star Vista's crisis line 650-579-0350 (as specified in the RFP).
  - c. Page 27, section J: Within 60 minutes of the individual being determined to require mobile crisis services in urban areas of the County; and within 90 minutes of the individual being determined to require mobile crisis services in rural areas of the County; these regions may include El Granada, Moss Beach, San Gregorio, Loma Mar, and Pescadero. Response time indicated in the RFP is 1-hour. These are Star Vista's protocol response times.
  - d. Page 26, Section I: "The SMMCR services shall be provided where the individual is in crisis, or at an alternative location." This is also how Star Vista operates. My question is if I am calling 911 about a person screaming about space aliens, why should I be asked whether there's an alternative location?
- 3. Page 16, bottom paragraph: "Mobile crisis services shall be available to all callers experiencing a behavioral health crisis." Fine, on its face, but what if I'm calling about someone who's standing at the intersection of Main Street and El Camino Real screaming that aliens from outer space are coming to get him?

## **BOS Proclamations**

Next week the Board of Supervisors will proclaim September as Recovery Happens Month and Suicide Prevention Month. It's always nice when commissioners make a public comment, saying how important it is to recognize recovery and suicide prevention. We do have speakers lined up, but your presence, as part of the Commission, really makes a difference.

### Office of Education Workgroup

The Health System has embarked on a partnership with the County Office of Education to look at mental health services in schools around the county, Commissioner Frieda Edgette is part of the work group. The title is "United for Youth Blueprint for School Transition Age Youth Wellbeing". It will try to coordinate some of the services that we are seeing, and what will be that blueprint to address mental health services in the schools. I think there is a big connection with some of the work that your Youth Committee is doing. I think young people that Commissioner Frieda talked about are involved in that workgroup and I just wanted to say, thanks to folks that were invited.

### Care Court

We are going to try to schedule a presentation from my team about Care Court. Care Court is a community assistance, recovery and empowerment court. It was a bill that passed last year. It's really expanding how people get mental health services locally. While San Mateo is not geared up to start Care Court until next year, we believe that engaging the community, telling you what we are hearing. getting your perspective will be important

as we continue to hear the challenges and the opportunities. There are 5 counties that are set to start Care Court this year, we are trying to learn from them both what are the barriers and what are the opportunities? And one of the things that we really learned is that we that they suggested that we go to different parts of the county to hear and share with people what the law/bill is and get feedback. Our team is going to come to the Behavioral Health commission to hear and to share with you what the program implementation would look like and get your thoughts.

### Data Book

In October, Scott Gruendl, Assistant Director, will come to present the Data Book. Part of your role as the Behavior Health Commission is to review the data that we submit to the State. Unfortunately, we have not received the current year, we're delayed from last year.

### First Six Months

This week highlights my 6 months of stepping in this role. It's been a roller coaster ride being able to meet our providers, meet clients, and their family members, and meet our staff. I really am doing my best to meet everybody and have a chance to talk to them. I will say that in my 6 months here, there are many priorities, there are many great things happening but the one thing that really has been on my mind is the workforce shortage. I am really worried about the workforce shortage, not just with the county, but with our providers. We are competing with every single county, in every single entity that provides mental health and substance use services, it is concerning to me on many levels. We are looking at the data. We are also trying to figure out what are the barriers of people being interested in applying to our jobs? We have jobs that have been posted for months and no hits. I'm thinking about ways to retain our staff, and to actually get people to be interested in our recruitments. As I continue in my work I'm thinking, with our staff, what better way to really create a culture that's focused on wellness and safety and that is client-centered. So those are the things that I really am worried about.

## **Upcoming Events**

Sylvia will talk about the suicide prevention month during her presentation. Someone already talked about the recovery month. ODE (Office of Diversity and Equity) is sponsoring in conjunction with the spirituality initiative, the National Day of Prayer on October 10<sup>th</sup>, Supervisor Corzo has been invited to be one of the speakers. We have heard from family members and clients that having faith and spirituality really helps with their recovery. The effort has been driven by clients and family members. It's non-denominational, it's how people understand and embrace whatever faith they have.

#### Housing

The Board of Supervisor's priority is housing, and we also know that many people who have behavioral health issues also can be unhoused and are oftentimes at risk of losing their house or are homeless. And so, we are paying attention to how to support those folks? We provide the supportive services that are critical in their recovery. First housing includes supportive services. Those folks that are in the housing arena that support our work, we want to recognize them. We are going to have our Housing Heroes Celebration Awards ceremony also in October. We want landlords to provide housing to our people who have mental health and substance use conditions. We want them to be our partner. The goal is to really honor people who have helped with housing our clients.
