- The Centers on Homeless report that In San Mateo County an estimated 1700 individuals are experiencing homelessness.

 - Without stable housing people are less likely to engage in anything else.
 - People experiencing homelessness often face poorer health outcomes.
 - Behavioral health clients, housing is part of treatment and directly correlated to recovery.
