PRESENTATION

CARE Court (See attached slides)

Presented by Ally Hoppis, Clinical Services Manager, Behavioral Health & Recovery Services and Gina Beltramo, Lead Deputy County Attorney, County of San Mateo

- CARE Court is a community-based behavioral health service and supports those living with untreated schizophrenia spectrum or other psychotic disorders through a new civil court process. It is intended to address revolving-door homelessness, short term hospitalization and incarceration. This is a new law and incredibly complex.
- Presentation includes how to make a referral, eligibility, court process, BHRS' role, services and goals & challenges.

Public Comment on Presentation:

Comments and response to questions

- Laura's law will not be impacted. The two programs will be blended. If someone is with AOT and they're ready for a step down, they could even step down through CARE Court if that seems appropriate.
- Even if someone is not eligible, our goal is to give people the proper hand off. Our team spends a lot of time with anybody who comes our way, and that is our plan for CARE as well. What is great about AOT and hopefully with CARE is that it is a great catch-all for people who just don't know how to connect to services.
- We are working with law enforcement, as they already do with AOT, so they can send us names and referrals. We'll work with field crisis and then offer it to other law enforcement agencies.
- Everyone who is referred gets legal counsel. Staffing will be part of Ally's BHRS team.
- Re: people who are repeatedly hospitalized for mental health reasons but don't feel they are ill: the hospital has reached out on many occasions and their team will work with the client and their family to try to get the person connected. Neither AOT or CARE Court force a person to do anything, but a lot of times it's the connecting of resources and engaging the clients in order for them to voluntarily accept services. We also get a lot of referrals from NAMI.
- The client number of 300 comes from Medical Center, correctional health and AOT ineligible list.
 There are a lot of avits in place throughout this program. If they are not argaging the judge might
- There are a lot of exits in place throughout this program. If they are not engaging the judge might decide to dismiss. If a respondent wishes to extend the program, they may also request that.
- The team may spend an average of 2-3 months to persuade patient to services. Sometimes quicker, sometimes longer.
- We are just receiving the first sets of data from counties that are part of 1st phase to the state and waiting for a lot more. We've seen other participating counties seem to be getting more voluntary engagements. Majority are seeing petitions are coming from families. A month ago, out of 8 counties, there were about 300 petitions.
- Re: Private insurance: It won't prevent anyone from receiving services. The law states MediCal is the last billing resort, but insurance will not be a barrier.

• Re: What staffing looks like for building trust with people to connect to CARE Court: This is why blending with AOT is important because they do this difficult work already. AOT has a license clinician, a mental health counselor, and a part time deputy public guardian. They are accustomed to working with this population and the team will also add a peer support worker and two more licensed clinicians.

- Continue to work with Telecare to get the mobile crisis up and running: 1 team in May, 5 teams in September
- Continue to look for locations to find any opportunities for housing clients with behavioral health issues; looking at hotels
- 2024 Mental Health Month's theme is Heal Through Connection #SMCAgainstLoneliness to align with Board of Supervisors declaration of the loneliness emergency.
 - \circ Their next meeting will be in-person on 5/2 at 310 Harbor Blvd, Belmont.
- Prop 1 has passed; we have enough time to come up with a plan to align with the regulations; no changes will happen until 2026.
- We hired our permanent OCFA Manager, Jana Spalding

Public Comment on the Director's Report

- Re: Prop 1 passing, MHSA bylaws do not need to change yet. We cannot do any changes without a
 community planning process. With the passing, one area (MHSA) will no longer be the focus, we
 have to really look at the system as a whole. We may need an external sort of support because this
 is a massive review.
- Youth SOS will not go away. It will be combined with the mobile crisis so there are not three different numbers to call. Just one number. Peer Specialists will be part of that team response for mobile crisis.
- Gap in the mobile crisis team that these teams will not be able to be dispatched by city law
 enforcement to provide a clinician only response to the CWCRT program.
- SMMCR should consider a more compelling, wholesome, attractive name.
- Have clinicians to have radio capability to talk to 911. Team is figuring out the rules around confidentiality, do they carry radios or not, etc. Have lots to learn as we pilot.
