# WHAT IS THE COMMISSION ON DISABILITIES?

- Established Sept. 10, 1991 (BoS Resolution 55400)
  - Combined Disabilities Task Force and Coordinating Council on Developmental Disabilities
  - Motto: Create, Educate, Advocate, Celebrate!
- 15 members (currently looking to fill 2 seats)
- General Meetings: Every 4<sup>th</sup> Thursday of each month at County Center
  - No meetings in July or December
  - Public can attend virtually

# COMMITTEES

- Executive (2nd Wednesday each month)
  - Officers and Chairs of each committee
- Advocacy, Outreach, and Legislation (2<sup>nd</sup> Monday each month)
- ADA Compliance (1<sup>st</sup> Thursday each month)
  - Reps from San Mateo County departments: Public Works, County Parks, Human Resources, Real Property Services, County Attorney, and the County Executive's Office

# COMMITTEES

- Accessible Transportation (4<sup>th</sup> Monday each month)
  - Reps from SamTrans
- Special Events (ad hoc)
  - Inclusion Festival and Disabilities Arts Showcase
- Youth & Family (re-building year)
  - Plans Transition to Independence Fair (TIF) in collaboration with high school districts

# PURPOSE AND GOALS

- Advise the BoS on disability-related issues
- Educate residents of San Mateo County on the needs of people with disabilities
- Create leadership opportunities for people with disabilities
- Advocate for people with disabilities on system-wide issues, especially safety
  - Emergency preparedness
  - Abuse prevention; improving resources for victims of abuse
- Collaborate with other agencies and organizations to mutually benefit the disabled community

# ACCOMPLISHMENTS SINCE OCT. 2024

- Hosted Disabilities Arts Showcase (Hall of Justice gallery)
- Wrote letter supporting County's plan to include a Quiet Room in 500 Building; recommended Quiet Rooms in all County buildings.
- Supported Capital Improvement Projects by assessing and recommending barrier removal initiatives across San Mateo County, including projects such as the North Fair Oaks Library and the El Granada Barrier Removal Project.
- Held a Virtual Town Hall to assess emergency needs of disabled residents; shared info with Dept. of Emergency Management



# ACCOMPLISHMENTS SINCE OCT. 2024

- Wrote letter supporting continued financial support for Community Wellness and Crisis Response Team program and recommended making it County-wide
- Updated Bylaws and created Governance and Tabling Calendars
- Wrote letter recommending “Demystifying Disability” by Emily Ladau for County staff
- Hosted 6<sup>th</sup> Annual Inclusion Festival at County Center (first time at this location)
