THE POSITION

The County of San Mateo's Health Emergency Preparedness Program is interested in identifying contractors with experience in creating and updating multi-agency coordination specifically with Public Health for the position of **Emergency Preparedness Special Project Coordinator**.

Proposed Terms of the Contract: Subject to compliance with all terms and conditions, the term of this Agreement shall be from July 22nd, 2019 through March 30th, 2020. The estimated value of the contract is \$99,500. This opportunity can be renewed based on the needs of the program and funding. This is a non-benefited position.

This position is in San Mateo County Health's Emergency Medical Services Division located in South San Francisco, CA, but will drive/travel throughout the County to perform duties of the job. The contractor may also have limited travel to the San Francisco Bay Area and Sacramento. The County will not reimburse any travel costs.

Scope of Services

- Update the Region II Medical Health Multi-Agency Coordination (MAC) guide with comments and suggestions based on the multi-agency coordination table top exercise
- Create and implement the improvement plan from Region II MAC table top exercise held on May 30th, 2019
- Exercise the updated MAC Guide with the Association of Bay Area Health Officials (ABHAO) Health Officers
- Work with San Mateo County Health Emergency Preparedness (HEP) Unit and Regional Health Officers
- Create notification for ABAHO Health Officers and MAC
- Update San Mateo County HEP plans
- Create San Mateo County Health Emergency plans
- Participate in HEP trainings, workshops, and table top exercises
- Provide support for MRC

**Services will be monitored and supervised by the Health Emergency Preparedness Manager

Duties include, but are not limited to the following:

- Solicitation of stakeholders to review existing plans/documents which may include emergency management officials from the state, other counties, regional governments, cities, and special districts to coordinate work efforts.
- Ensure MAC Guide updates based on stakeholder review
- Conduct and coordinate training and exercise for Health Officers and stakeholders
- Perform related duties to support Health Emergency Preparedness functions
- Create and update San Mateo County Health Emergency plans
- Must attend meetings with the HEP staff to discuss project related work
- Must collaborate with the HEP staff on a regular basis to discuss project related issues and concerns
- Must have weekly check ins with the HEP Manager

- Prior experience working with ABAHO and Region II Medical Health Operations Area Coordinators (MHOAC)
- Demonstrated success in plan writing, project management and program coordination
- Experience implementing emergency management strategic plans and work plans
- A thorough understanding of phases of emergency multi-agency coordination
- Experience with public health emergency functions and preparedness activities
- A strong background/understanding of the allocation of resources crossing agencies in an emergency needed to support an incident during a disaster
- Techniques for effectively representing the County in contacts with governmental agencies, community groups, and various business, professional, educational, regulatory, and legislative organizations
- Experience facilitating and leading professional groups in decision making processes
- Experience in facilitating group discussions with professionals of different backgrounds
- Experience with organizational and management practices as applied to the analysis, evaluation, development, and implementation of programs, policies, and procedures
- Strong oral and written communication skills
- Proficiency in Microsoft Office Suite

Qualifications:

- Bachelor's Degree in one of the following fields: emergency management, business administration, public administration, public health, communications, criminal justice, or a related field
- Must have experience in medical health multi-agency coordination (MAC) guide writing in the past three years
- Must have historic knowledge of the current Region II MAC guide
