## CLINICAL PEARL

Patients with symptoms consistent with COVID-19 should be tested without delay using either polymerase chain reaction (PCR) or antigen tests. Testing these patients in a timely fashion is important especially if participating in work, school or sports, so that local public health workers can begin contact tracing, outlining work/school closures, and notifying families to begin home quarantine until test results are available. Asymptomatic patients with close contact exposure to infected persons should not be tested until at least 4 days after exposure. With faster diagnosis of infected persons using rapid antigen testing, there is pressure to have close contacts immediately tested. However, it is important to advise exposed patients to quarantine and wait to test until at least day 4 in order to limit false-negative results and to limit the need for sequential testing. The probability of a false-negative result in an infected person decreases substantially over the first 4 days after exposure. Because symptoms develop 2 to 14 days following exposure and most commonly between 5 and 6 days, further testing after a negative test result should be guided by symptomatology. Testing is generally not recommended for indirect exposure such as exposure to a close contact and not directly with the infected person, unless the close contact subsequently tests positive or develops symptoms. Testing is also not recommended for asymptomatic patients who have previously tested positive within the past 3 months. Because patients can continue to test positive for several weeks and possibly longer without being infectious, a negative test should not be necessary for return to work/school clearance.

## PUBLIC HEALTH UPDATE


