1. Staff

- 1.1 Ambulance Staffing
 - 1.1.1 One currently licensed and accredited paramedic in San Mateo County and one EMT-I who has 40 hours of county approved advanced training or two paramedics.
 - 1.1.2 During patient transport, the paramedic will remain with the patient.
- 1.2 First Responder staffing
 - 1.2.1 Shall be staffed with a least two personnel, at least one of whom shall be licensed and accredited as a paramedic in San Mateo County.

2. Medications

The following are approved medications and minimum levels to be carried on all San Mateo County emergency paramedic ambulance, EMS Supervisor, and first response apparatus.

- 4. Restocking Of Medications, Medical Supplies and Equipment

Providers of paramedic emergency ambulance and first response shall be responsible for restocking their respective apparatus. While providing service onboard medication, medical supplies and equipment stock will decrease. On-duty paramedics are responsible for ensuring in-service ambulances and first response apparatus have appropriate levels of medications, medical supplies and equipment on-board per this policy. When needed, the on-duty supervisor will be requested to restock. The on-duty supervisor will ensure the timely resupply of apparatus to maintain the minimum levels per this policy.
