• Help at Home

- Owdom reported progress on reformatting Help@Home. After completing content input, the committee will review existing pamphlets to determine the preferred direction and structure.
- Formatting: Chair Lee and Staff Liaison Sawamura will collaborate on layout and formatting after content input is complete.
- Scope Clarification:
- The guide is a resource directory; it is not intended to provide prescriptive advice on how individuals should or should not age.
- **Tabling:** Estimated cost to table at community events is approximately \$500–\$600 per event; potential scheduling for next year was discussed.

• Buddy assignments

Commissioners will serve as “buddies” to make connections with senior centers, nonprofits, and related organizations.

- A phased approach was discussed (initially broader outreach, then narrowing to a smaller set); details and counts were referenced but not finalized.
- Local Age-Friendly Work

Report back noted that 13 cities have action plans. CAFE is supporting cities to create/renew work plans.

- References were made to Redwood City (RWC), North Alameda County, and ADRC; no specific actions were recorded.

 - Ideas included “Villages,” buddy-event tie-ins, and an “EDAPT” scams concept; the committee noted the need to submit a formal proposal to the Executive Committee for January.
