<p>Reminder about Diagnoses!</p> <p>MIS has found that claims are being submitted without ICD-10 codes due to diagnoses not being entered at admission and/or not being updated along with the completion of the assessment. WITHOUT AN ICD-10 code attached to the client's chart, we are UNABLE TO BILL. Remember, the diagnoses that is submitted with claims is the diagnosis that is entered on the Diagnosis Form for your episode.</p> <p>Please remember to complete the Diagnosis Form (included in the Admission Bundle and in the CalAIM Assessment bundles) on admission and any time you update the client's diagnosis in the assessment.
