I. Executive Summary

MED-Project LLC ("MED-Project") operates a Product Stewardship Plan for Unwanted Medicine from Households ("Plan") in San Mateo County (the "County") under the County of San Mateo Safe Medicine Disposal Ordinance, San Mateo County Ordinance Code 4.116.010 - 4.116.190 ("Ordinance"). The San Mateo Environmental Health Services ("Department") approved MED-Project's revised Plan, dated April 15, 2019, on January 16, 2020 ("Approved Plan"). This 2020 County of San Mateo Annual Report ("Report") describes MED-Project's activities between January 1, 2020, and December 31, 2020 (the "Reporting Period"). All capitalized terminology not defined in this summary is derived from the Approved Plan.

Notifications in the Reporting Period

MED-Project submitted a number of change requests and notices during the Reporting Period providing status updates related to the effects of the COVID-19 pandemic, which are discussed in the following section. The notices included:

- A notification from MED-Project informing the Department on July 20, 2020, that MED-Project's Vendor would temporarily engage a subcontractor to service Unwanted Medicine kiosks at MED-Project kiosk host sites from July to November 2020.
- A notification from MED-Project informing the Department on November 23, 2020, that it was expanding the list of Reverse Distributors in the Approved Plan.

COVID-19 Pandemic-Related Notifications

MED-Project sent the Department an initial COVID-19 pandemic response notification on March 17, 2020, and a second COVID-19 pandemic response notification with additional information on March 26, 2020. On April 19, 2020, MED-Project provided a third COVID-19 pandemic response notification, which included information about sites with COVID-19-related restricted access. On July 16, 2020, MED-Project provided a fourth COVID-19 pandemic response notification, which detailed continued or new kiosk drop-off site access restrictions related to the COVID-19 pandemic. On December 14, 2020, MED-Project submitted a fifth COVID-19 pandemic response notification, which indicated that 14 Unwanted Medicine Kiosk Drop-Off Sites remained restricted. Appendix B, Kiosk Drop-Off Site Locations provides additional details about sites that reported restricted access statuses due to the COVID-19 pandemic during the Reporting Period.

Reporting Period Operations Overview

During the Reporting Period, priority was given to establishing Kiosk Drop-Off Sites throughout the County, and performing outreach to eligible pharmacies, hospitals, and clinics with on-site pharmacies, and Law Enforcement Agencies ("LEAs") throughout the County. As a result of these efforts, MED-Project's Program collected and disposed of Unwanted Medicine from 49 Kiosk Drop-Off Sites and distributed Mail-Back Packages for disposal at 19 Mail-Back Distribution Locations.

Kiosks were installed in pharmacies and hospital/clinics with an on-site pharmacy that meet all local, state, and federal requirements and that executed agreements with MED-Project. In addition, outreach and educational materials, including signage and/or brochures, were distributed to all newly activated Kiosk Drop-Off Sites.

MED-Project provided disposal instructions for Kiosk Drop-Off Sites and Mail-Back Services to Residents and continues to communicate with Kiosk Drop-Off Site Hosts to distribute outreach materials upon request, review procedures as needed, and improve overall Program design.

As outlined in the Approved Plan, the ultimate goal of the Program is to provide Residents with convenient, safe, and accessible methods to dispose of Unwanted Medicine. MED-Project anticipates a steady increase in Kiosk Drop-Off Sites through 2021 as a result of ongoing outreach and Program activities, especially if there is increased retail chain pharmacy participation in the Program.

The following sections of the Report respond to specific reporting requirements pursuant to Ordinance Section 4.116.090. Each section of the Report restates the corresponding Ordinance requirement and provides the required information.

A. Kiosks

MED-Project collected a total of 33,411.2 pounds of Unwanted Medicine through Kiosk Drop-Off Sites.

B. Mail-Back Packages

MED-Project collected a total of 12.3 pounds of Unwanted Medicine through the return of Standard Mail-Back Packages during the Reporting Period.

C. Total Weight of Collected Unwanted Medicine

MED-Project collected a total of 33,423.5 pounds of Unwanted Medicine through Kiosk Drop-Off Sites and Mail-Back Packages.

IV. Kiosk Drop-Off Site Locations, Mail-Back Package Distribution, and Collection Events

A total of 111 Mail-Back Packages were distributed directly to Residents. Disabled and/or home-bound Residents, and persons providing services to such County Residents, were able to request Mail-Back Packages through the Call Center and/or MED-Project Website. MED-Project identifies a total number of Mail-Back Packages provided directly to residents because it is unable to verify whether the recipient is disabled and/or home-bound, or a person providing services to such County Residents.

MED-Project distributed 320 Standard Mail-Back Packages to 19 Mail-Back Distribution Locations.

A. Public Education Activities

MED-Project provided disposal instructions for Kiosk Drop-Off Sites during the Reporting Period. In addition, MED-Project maintained a website and toll-free number to provide information pertaining to MED-Project disposal options and outreach materials. The Website, toll-free number, and outreach materials, such as posters and brochures were available in the required languages, including English, Spanish, Chinese, and Tagalog. MED-Project Website information and statistics are provided in Appendices H and I, respectively.

B. Outreach Activities

To promote the Program during the Reporting Period, MED-Project provided print, digital, radio and television campaigns; provided information through the MED-Project website; posted information on social media sites; and sent email blasts. Additionally, MED-Project distributed materials, including brochures and posters, to Kiosk Drop-Off Sites. See Appendix J for examples of brochures and posters. In accordance with Section XI.D of the Approved Plan, MED-Project is providing a log of when each

stakeholder was provided with educational brochures during the Reporting period. See Appendix K; Educational Brochure Distribution Log. C. Evaluation Activities

As required by Ordinance 4.116.060(a)(4), MED-Project conducted a biennial survey of Residents, pharmacists, veterinarians, and health care professionals who interact with members of the community after the first full year of Program operation. The survey was conducted in September and October 2020, and the results were posted to the MED-Project Website on January 15, 2021. The survey provided MED-Project with information on the effectiveness of promotion, outreach, and public education in the County. 35% of San Mateo County Residents surveyed remember having been exposed to messaging in the previous year about safely storing/disposing of expired and/or unwanted medicine. Additionally, of the Residents surveyed, 35% reported using drop-off locations or mail-back methods to dispose of medicine. Of this group, 92% used Kiosk Drop-Off Site locations. Of Residents who have used medicine drop-off sites, 79% believe the medicine disposal Program is easy to use, and 76% of the same group of Residents believe locations are easy to locate.

VIII. Packaging Recycling

Ordinance Sec. 4.116.090(a)(10): "A description of how collected packaging was recycled to the extent feasible, including the recycling facility or facilities used."

As described in the Plan, while drug packaging is expected to constitute a significant amount of the waste incinerated under the Program, MED-Project has concluded that separation of inner and/or outer packaging from Unwanted Medicine and/or recycling of packaging would raise three significant concerns:

- 1. Separating and recycling drug packaging could result in the disclosure of confidential patient information appearing on prescription drug packaging;
- 2. Separating and recycling drug packaging could increase the potential for releases and leakage of Unwanted Medicine; and
- 3. Separating and recycling drug packaging could increase diversion risk by adding additional steps to the collection process and because drug packaging is often used in drug counterfeiting, the drug packaging could be a diversion target itself.

For these reasons, the Program does not provide for the separation and recycling of packaging from Unwanted Medicine.

MED-Project education and outreach materials instruct Residents to return Unwanted Medicine at a Kiosk Drop-Off Site, via Mail-Back Services, or at a Take-Back Event, in its original container or a sealed bag. These materials encourage Residents who transfer their Unwanted Medicine into a sealed bag to recycle all remaining packaging.

IX. Program Goals

A. Collection Goals




Figure 1: Map of Kiosk Drop-Off Sites and Mail-Back Distribution Locations

MED-Project strove to meet the Service Convenience Goal goals in Ordinance Section 4.116.050(b) during the Reporting Period through established Kiosk Drop-Off Sites Locations as provided in Appendix N; Kiosk Drop-Off Site Reporting Period Results. Figure 1 shows a graphical representation of the Service Convenience Goal during the Reporting Period with Kiosk Drop-Off Sites Locations.

MED-Project continues to strive to meet the long-term goals and satisfy the service convenience goals. Additionally, MED-Project anticipates the average pounds per Kiosk Drop-Off Site to increase in 2021 with increasing public awareness of the Program. Refer to Sections III and IV of this Report for specific collection information.

B. Education and Public Outreach Goals

MED-Project performed a review of the survey results to evaluate media and public outreach in order to make any adjustments and improvements to the Program.

MED-Project released a Public Service Announcement ("PSA") animation directed at Residents on social media websites, digital media, and broadcast television platforms.

MED-Project conducted outreach with a combined target reach of 50% at a 2+ frequency for the duration of one month more than three times in 2020. See Appendix M; Media Outreach Summary.

MED-Project will continue to evaluate media and public outreach as well as collect feedback by survey in order to make adjustments and improvements to the Program. Additionally, MED-Project may revise and/or add communications materials based on changes to the Plan.

C. Collector Outreach

MED-Project continued collector outreach by issuing letters to all potential Kiosk Drop-Off Sites on February 28, 2020. Phone calls were made, and emails were sent to eligible sites that did not respond to the letter. Eligible non-participating sites were contacted until either the site began participating in the Program or the site indicated they no longer want to be considered for participation.

X. Program Costs

Ordinance Sec. 4.116.090(a)(12): "The total expenditures of the Stewardship Plan during the reporting period."

The total Program cost for the Reporting Period was \$1,702,651.39¹.

Safety and Security Report

Event: Collection Site Unwanted Medicine Box and Liner Shipping Discrepancy

Date: September 29, 2020

Description: Vendor notified MED-Project that Carrier tracking data suggest the Carrier delivered a collection site Unwanted Medicine box and liner originating from a San Mateo County collection site to Vendor's reverse distributor location on October 5, 2020. Vendor's data does not indicate receipt of this Unwanted Medicine box and liner. The Vendor reported conducting and completing an internal investigation to confirm that the box was not received via a process outside of the standard receiving protocol at the Vendor's reverse distributor location. The Vendor also reported initiating an investigation with the Carrier, which conducted its own internal investigation. The Vendor informed MED-Project on November 16, 2020, that it had concluded its investigation with the Carrier and the Carrier confirmed the box and liner as being unaccounted for. This apparent discrepancy could result from data capture and processing issues, diversion, or potentially other causes. The Vendor has previously reported that the Carrier has policies and procedures for managing packages containing pharmaceuticals that it cannot deliver or return, including destruction at a permitted medical waste incinerator. For example, these procedures may apply if the shipping container label was damaged and could no longer be tracked to a shipping destination.

Corrective Action Taken: Based on discussions with MED-Project, in early 2020 the Vendor implemented reporting to MED-Project to identify any Unwanted Medicine boxes and liners that enter the Carrier's network but are not recorded as delivered to Vendor's reverse distributor location within established timeframes. The Vendor performs a monthly reconciliation of the Carrier's tracking data for Unwanted Medicine boxes and liners shipped with Vendor's data for Unwanted Medicine boxes and liners shipped with Vendor's data for Unwanted Medicine boxes and liners received. The Vendor identified the shipping discrepancy through the monthly reconciliation. The Vendor reported that they will continue to follow-up with the Carrier to ensure all available information regarding the shipment is provided. In addition, the collection site was informed of the shipping discrepancy and notified to evaluate potential reporting obligations.




Figure 3: MED-Project Website Check the Package Page (December 2020)




Figure 4: MED-Project Website Convenient Locations Page (December 2020)






Figure 10: MED-Project Brochure English (Back)
