BHRS Budget FY 19-21 Brainstorming

Brainstorming Session Goals

- 1. Understand "Why this, why now?"
- 2. Financial Position
- 3. Approach to Budget Development
- 4. Describe process for seeking input from stakeholders and providing updates, setting the stage for open and clear communication
- 5. Convey high level timeline for deliverables
- 6. Gather ideas for solving the FY 19-21 gap

Why this, why now?

- County Manager's Office (CMO) has requested that departments prepare for:
 - Potential economic downturn
 - Likely risks with federal, state and county revenues
 - Potential increase in obligations for negotiated Labor agreements and cost of doing business in the county
 - Paying down the pension liability through FY2023
- Requires a potential 2.5% reduction in Net County Cost Revenue

Financial Position Pressures on BHRS Revenues

- Reimbursement for Medi-Cal services could be negatively impacted by possible change in federal policies
- Realignment funds are growing more slowly than expected
- MHSA funds are under pressure at the state level
 - Proposal to use MHSA funds for housing projects on ballot in November
- Net County Cost probable reduction of 2.5%

Financial Position Growing Expenses

- The largest cost drivers of the BHRS budget are growing faster than revenues:
 - Salary and benefits
 - o "Bed Budget" Placement costs facilities
 - o Contracts with our Community Based Organizations
- In addition, state and federal audits will result in the need to repay funds

Financial Position FY19-21 Projections

- Projections are being refined (not final yet)
- Gaps are significant and require proactive planning
- Current identified gap:
 - Deficit of at least \$8.9M in FY 2019-20
 - o Deficit of at least \$11.2M in FY 2020-21
- No additional net county dollars available to cover FY 2019/21 projected shortage

Approach to Budget Development

- Approved plans will be implemented in two phases:
 - o Phase 1: July/September 2019
 - o Phase 2: July 2020
- Will include:
 - Revenue maximization
 - Expense review
 - o Use of reserves as **one-time** solutions to help with phased implementation

Stakeholder Process: Budget Principles

- All decisions will be grounded in the context of the County and Health System principles
- Including but not limited to:
 - Transparency
 - Commitment to longer and better lives for all residents with no gaps by race, ethnicity, geography or other demographic factors
 - Prioritize and will not compromise the safety of our clients, staff or partners as a precondition for furthering health for everyone we serve, our workforce and network of partners
 - Involve those affected by potential recommendations in our budget planning process

Stakeholder Process: Assessment

- All proposals will be assessed with the following parameters in mind:
 - Gauge ideas grounded in principles
 - Effort to implement/level of return
 - o Revenue generation and expense controls equally valid
 - Programs funded with dedicated dollars (fore example, MHSA, Measure K) cannot be reduced, but can be optimized
- There will be a process for communicating back with stakeholders

High Level Timeline

- Proposals must be presented to the Health System in November
- BHRS internal timeline: proposals must be submitted no later than the third week of October
