Resources and Scenarios

CIT isn't a stand-alone response team, we have a system that works together:

- Crisis Intervention Training (CIT)
- Psychiatric Emergency Response Team (PERT)
- San Mateo County Mental Health Assessment and Referral Team (SMART)
 - o Coverage from 8:00 a.m. 10:00 p.m. with specially trained paramedics
- Family Assertive Support Team (FAST)
 - o 2 family support members, 1 therapists, 2 peer support members
- Field Crisis Teams
 - Meet once a month with all police departments and the public defender's office
- Crisis System Collaboration

When we began the CIT Program we had two classes a year. We now have four classes a year with 50% of all County jurisdiction officers trained. East Palo Alto and Brisbane officers are fully trained.

It is now mandatory in California that all officers have at least 15 hours of CIT training.
