Director's Report

Remobilization

BHRS is ready to move into the next phase of the remobilization work. On June 15, we will be opening all our public facing services. What that means for us is that our buildings will be open to the public again. All our services will take walk in crisis. We are still doing a lot of planning. As an employer we will follow CAL/OSHA rules.

We will move forward with the most strict rules that are in place. Mask wearing, social distancing, hand washing, and the number of people in a room. It does limit our ability in

some of our buildings. It will be an ongoing series of steps and phases that we will go through.

Vaccine Efforts

We continue to offer concierge type services to our clients. Over the past week, we had three different events staffed by BHRS staff to help our folks get vaccinated. We're finding at these events approximately 50-60 people are coming to each of them. We need a predictable space where people know there's going to be a vaccine and staff and start working to get folks there instead of the pop-up clinics, we are working on that. We are giving incentives (\$10 gift cards) for each dose. Any client who receives a vaccine is entered into a drawing for a \$50 gift card. We are doing a post vaccine survey to find out if it really makes a difference.

Public Comment

How do consumers get vaccination gift cards?

A: You have to go to one of the BHRS clinics, we'll post the flyers for the clinics in the chat.

Jean Perry – As things open up, I hope that priority will be given to getting Field Services going again. People will be able to do outreach to the community, that's very important wasn't totally bridged with technology.

In your Director's Report in the article about Arroyo Green Senior Housing opening up with some MHSA units and in the last paragraph you mention it's the last of the MHSA funded housing program unit and the good news is that it's using our one-time funds. One of the suggestions of the Housing Task Force is that we use of those one-time funds to set up for this fiscal year and the next fiscal year sufficient funds to allow 24 more units to happen over the next year.

Chris Rasmussen

We'd been talking a lot about the mental health and substance misuse go hand in hand. We have an Older Adult, Children & Youth Committee, maybe we need to look at creating a substance misuse committee. Maybe this is something we can discuss at our retreat.

John Butler

Fortunately, isolation hasn't been much of a barrier for me thanks to decades of major depressive disorder, I managed it pretty well plus I have two cats. Can we move from fist bumps only to a hand on the shoulder or a hug, by agreement? Or are hugs out of the question on June 15?

A: I think for vaccinated people we'll see a whole set of different rules.

Pat Willard

The Board of Supervisors will be talking about the budget over the next couple of weeks, has MHSA already submitted a budget to the County or is about to? If the 30-day public comment period includes things, I wish you had more clinicians on staff so they could better distribute them around the county. This 30-day comment goes beyond county approval. Should I wait for the BOS to say give MHSA more money?

A: The BOS doesn't allocate MHSA funds to us, that comes from the millionaire's tax. The BOS gives us general funds and Measure K funds. I know our county is more supportive

of behavioral health than most in terms of their generosity for our programs. The County is not the biggest part of our dollars, it's the realignment revenue, Medi-Cal revenue, those are our big dollars so I would say if you wanted me to hire more staff you would do better to speak here. This commission makes formal recommendations to the BOS and me so this is probably the best spot (on any topic) to voice your opinion. I think it would have a lot more weight coming from the commission.

Public Comments

Michael Lim

I would like to bring attention to a presentation made to the Suicide Prevention Committee from the Director of NAMI San Mateo County on the 911 process. We have Police Departments not being willing to 5150 an individual who is in a state of crisis and someone else needed to be brought in to persuade the police to issue the 5150. There have been a lot of incidents in the news over the past two months with regards to the 911 process. There were committees established by the Redwood City Police Department and the Belmont City Council to address the process of the mental health and 911 process and it was less than adequately handled. I was wondering since the commission is in the situation of advising the Board of Supervisors with what is happening in the county, if we could have a regular update on what process the other city Police Departments are doing and also the Sheriff's Office, especially with the pilot program that is happening.

A: The committee from Redwood City is not a mental health advisory board it is a police advisory commission, so we have no jurisdiction. Belmont is doing their own crisis program.

Randy Torrijos

I am interest in a point that Michael made regarding 5150's, maybe that is something the Ad/Hoc Committee can discuss. The question about going to cities is more of a jurisdictional inter-government agency wide situation which has its own complexities. Regarding the mental health issues, I do think it would be beneficial to this group to understand the process of 5150's and exactly how that should and should not be used. I know it involves criminal conviction, there might be mixed messages on whether it should be used.

Martin Fox

Sheriff Bolanos announced the implementation of Enhanced CIT Training at the La Honda Police Forum that was held on April 26. On May 12, you will find at Sheriff's Bulletin on the website, describing an incident on Quarry Road where there was a successful disengagement and that's the result that he predicted would occur at the police forum. It is my understanding CIT training will be enhanced and changed and the Sheriff will seek approval from the State to include in the police officers' standard training. It is positive but there isn't enhanced treatment to go along with it.

Captain Bell – We've had it approved and are up and running. We have had two successful classes.

What does SLE stand for?

A: Silver Living Environment

Jean Perry

I am aware of Laura's Law and the Mental Health Court and it looks like there is also a Drug Court. There's a lot of individuals with mental health issues as well as substance use issues, how does someone in the judicial system access the specialty courts?

A: I know the least about Laura's Law, I know it is associate with AOT.

Drug Court is for people who are charged with possession and instead of doing time, if the District Attorney and the Private Defender agree, then the client can be referred and assessed for treatment. Probation and the Drug Court Team provide the client with case management services for about 18 months.

DUI Court is for people charged with driving under the influence. I'm not sure of the difference between DUI Court and DUI Programs. People with multiple charges can go to DUI court.

Pathways is for clients who have been charged but have a mental illness and their mental illness is directly related to the reason they were charged, they can be referred to mental health court and receive case management services. If they have co-occurring disorder then their Pathways Case Manager can refer them to treatment

Pat Way

Ho do you interface within the prevention arena with the group that runs First Chance?

A: We collaborate with First Chance Sobering Station; they are part of Star Vista. When someone is dropped off at the sobering station by the police their counselors will talk to them and when they are sober enough will talk to them about treatment and see if they want to get enrolled. They will also talk to them about medicated assisted treatment.

Jean Perry

I am aware that substance issues can be relapsing and I've heard that there is a limit to the number of times you can begin services, can you explain that?

A: When the State instituted the Drug Medi-Cal Organized Delivery System (ODS) they decided to limit the amount of residential treatment episodes a person could to 2 times per calendar year. The counties and stakeholders did not like that and expressed their collective concerns about that and the State eventually decided the counties could use additional funding sources to pay for additional treatment episodes. That restriction has essentially been lifted.

Martin Fox

The California Supreme Court ruling in the Humphrey's case that there is no more cash bail. That seems to put a lot of pressure on pre-trial services. Do we have someone watching the terms of anyone dealing with substance abuse issues under Humphrey?

A: I haven't heard of that law, I can look into it. Please send me an email with that information to dhill@smcgov.org and I will look into and let you know.
