Public Comment

Candice Hawley

The rankings that we received is great but let us not forget we have so much work to do. That ranking shocked me, as a black person there's no way I would think out of 1200 communities, I would put San Mateo County at the bottom. There are so many underserved people in this county.

#### Jean Perry

You mentioned Cal Aim, the possible secret code that cost cutting needs to happen in the prevention of services and that something that is not solved is for people who lack housing, finding the right fit for their housing. I know people who are housed but it does

not support recovery. Since there is more funding coming, how do we expand what we've got so that it fits what people need?

A: We're looking at a couple of ideas for how to do things differently. The county needs to buy the property and know that the place is going to get trashed, and that person will not be evicted, they need to remain there.

#### Michael Lim

I am encouraged to hear that we are ranked as high as we did, especially in our mental health services. It may not feel like we are on top of the heap but talking to other counties we are by far ahead of a lot of counties out there. Yes, there's a lot of work to be done. As far back as in the 60's when they ended the hospitals the funding has been short, so we've got decades of work to catch up on. I have confidence in our leadership team and executives with the county in terms of budgeting their one-time funds that we will be getting and making sure the reserves are used judicially. The state is working on Cal Aim and on July 1, the \$2,000 limit for Medi-Cal recipients is being increase quite a bit. One of the major challenges for our clients in that they can't save enough to get the things they need. Now they have an opportunity to save more than \$2,000 without losing their benefit.

Can you give us a report on the SMART car contract that was due July 1? It was a threeyear contract in 2019 and we haven't had any mention of it and how it works in San Mateo County?

Put a reference to the SMART car and the American Medical Response because the SMART car, according to measure K oversight committee, has failed to meet its target for three consecutive years. It is supposed to be the behavioral health emergency service that is supposed to serve the county and all the cities, with the exception of South San Francisco. It's really important to integrate it into all of the emergency services, especially when you start talking about changing dispatchers' scripts.

McGuire Correction Facility, Acute Stabilization Unit

Presented by Carlos Morales, Director of Correctional Health Services, Correctional Health Services

Acute Stabilization Unit

- Offers programs treating a range of conditions for the incarcerated
  - To meet the needs of those with mental health conditions that may have landed them in jail
  - o Present a threat to themselves or other inmates or staff
- The facility offers mental health services to male and female inmates who have mental health challenges and/or substance use disorders
- The stabilization unit is operated by Liberty Healthcare Corporation in coordination with county staff

#### Fixin San Mateo County

Presented by: Nancy Goodman, Executive Director, Fixin San Mateo County and Jim Lawrence, Board Chair, Fixin San Mateo County

#### Goal

Establish an effective community-based Sheriff Oversight Board and Inspector General, both with subpoena power, to address resident complaints, investigate issues, and make policy and practice recommendations.

#### Strategies

Develop and roll out a robust community-based campaign to persuade the Board of Supervisors to use their legislative authority to pass an ordinance for strong and independent civilian oversight.

**Public Comment** 

Paul Nichols

I'm confused by the branding, what is Fixin San Mateo County? What type of push back are you receiving from the Sheriff and law enforcement?

A: That is just the name of our non-profit. The Sheriff embraces our efforts. We met with the Board of Supervisors (BOS), and I'm pleased to report they are forming a committee to study this recommendation and hopefully move it forward. We are hoping to bring it to light before the end of the year.

Michael Lim

Question for Carlos. Are peer support services available to the incarcerated? What about clients who are youth?

A: We do not have peers in the jail, we do have non-licensed individuals who are working in the jail, we do have peers working with Choices. We only provide medical and dental services to youth; their treatment is provided by BHRS.

Question for Fixin SMC. Do you have plans to include justice involved peers on your oversight group?

A: We are going to have the community involved, if there is someone with that expertise they will be included.

Jean Perry

Two questions for Carlos:

- 1. McGuire is a men's facility, what services are available for women?
- 2. What happens with people who are transgender or transitioning?

A: The Behavioral Health program for women is at Maple Street. We do have women who utilize the acute stabilization unit, they put up privacy screens. We are considering moving some of the women to McGuire for sheltered living.

Yoko Ng

Fixin San Mateo County

I would like to learn more under reported incidents involving different diversity, other minority groups within our county.

Question from the chat:

How much would it cost to create the committee and where would funding come from?

A: We are using the Sonoma County method which s1% of the Sheriff's budget to fund the oversight committee.

Marine

I want to express my total opposition to a civilian oversight committee. It is a misguided agenda item, and the proposed ordinance is severely flawed. The composition of who would serve on the oversight committee is flawed, to see out people who have not been able to manage their own lives and put them in a position of overseeing the lives and careers of our Sheriff's would be a mistake and irresponsible. To put people who are in the country illegally in a position of authority over the Sheriff's would be wrong.

#### Johanna Rasmussen

I serve on the Juvenile Justice & Delinquency Committee. I come from a family who has worn a police badge for over 100 years. Three generations of the San Francisco Bay Area serving and protecting our community and I absolutely, 100% support the Fixin San Mateo County effort. This is not about, not having officers going home safely, this is not about a political movement or social justice warrior. Good officers' welcome oversight.

#### Mike

I agree with Marine's comments.

#### Martin Fox

Understand that the real proponents of this are the people who supported AB 1185 the chief proponent of this was the American Civil Liberties Union, they gave CalOSHA the Lanterman-Petris-Short-Act (LPS) in 1970 and has repeatedly refused to repeal or modify it in some fashion. As the parent of an adult child living with serious mental illness who has lived with adverse effects of LPS Act, I'm not surprised that the American Civil Liberties Union didn't show up here today like they did for the 05/17 BOS meeting and use some well-intentioned but grossly misled citizens to carry this in San Mateo County and ignore the fact that a very similar oversight committee in Santa Clara County was so ineffective that it had to give up seeking the removal the Sheriff there and go to the BOS who turned around and used the existing statues that allows a civil grand jury to investigate and remove Sheriff Smith. You will see the trial take place in Redwood City starting in September. This is completely unnecessary.
