		Germany and the importance of collecting data.

6.	AB 361 Allows for the continuation of virtual meetings of the Committee	Action Item: The MISO Committee will continue holding meetings by teleconference as a result of the proclaimed state of emergency and meeting in person would present imminent risks to the health and safety of attendees. All 4 Commissioners voted yes. Action item passed.
7.	Review of Work Plans	 Chair Dimas-Kahn began discussion on employment opportunities for older adults and working on a resource list of agency contacts. Commissioner Barr shared her experiences of conducting personal visits to the corporate offices of FaceBook, WalMart. AARP, Work Chrome, the Post Office, stores, restaurants and others. Many employment opportunities are available but to apply, the majority require completion of on-line applications. Committee discussed creating a list of questions to ask employment agencies on how they outreach to older adults and if training is provided for placements including assistance with on-line applications: full or part time employment? Computer literacy? Educational requirements? Transportation? Dexterity and physical requirements ie. Standing for long periods of time? Additional Comments from Committee Small local businesses may still be hiring in person and may be good options for older adult employment Job Readiness and ability to be work with technology are needed to develop new job paths for older adults How can we help employment agencies better serve older adults? Can we provide training ie. Resume development or how to research companies through the libraries in San Mateo County?
