| 6. Work Plan Activities - Long-Term Care Research | Commissioner Dimas-Kahn provided some input for the committee because she is terming out of the Commission on Aging this month. She suggested that the MISO Committee continue to accurately reflect our committee discussions in the monthly meeting notes. This will help keep the committee organized and moving forward. Plus, you can share the committee notes with other advocacy organizations. Along with recruiting more members for the committee. We need public members to help us brainstorm on how we can advocate for middle-income issues. Plus, she suggested reviewing the committee work plan in the upcoming months to make sure the actions items are still relevant for the upcoming year. Some action items might not be a priority for the current committee members anymore. Identify and prioritize gaps middle income seniors face in income, housing and healthcare to take it to the next level. Chair Austin agreed it was important to continue working on these gaps. Commissioner Barr brought up the information shared about the C4A Conference last month. She feels it's important to focus on the expansion of Medi-Cal, CalAim and Universal Basic Income. Commissioner Dimas-Kahn mentioned the Congressional Budget proposed budget indicates they want to increase the monthly Medicare Part B premium to \$458 in 2024. This is an example of how things will get worse for the middle income seniors in the future. Increased worries about seniors and their finances. 5. Commissioner Austin commented that he would like to learn more about Medi-Cal and Medicare because he never understood when he oversaw his mother's insurance coverage. 6. Public Member Sandra Lang said that as a long-term insurance agency it is really difficult to get recertified because you have to understand Medicare and MCAL. Commissioner Dimas Kahn offered to give a brief Medicare and MCAL tutorial at the next MISO meeting. She is not going to use a power point. Instead she is going to use the white board in the conference room. 7. Anna reminded us that the plan to learn about Medicare was a good idea, but suggested that we start with Plan A, B, and C to simplify the study process 8. Commissioner, Austin, agreed that our work plan should be manageable. 9. Commissioner Dimas-Kahn and Commissioner Austin agreed that we work on bringing in more ideas from the public to keep our work relevant. Such as notify the faith based communities about our work. 10.
