## Norovirus Alert – New Strain in United States

Currently, a norovirus GII.4 virus strain not previously identified in the United States (US) has been circulating in Australia. It has been associated with up to 84% of the strains typed in South Australia, 94% of the outbreaks in New Zealand and has replaced the GII.4 New Orleans (2009) variant in these countries. This virus has reached the US and has caused 14% of all reported norovirus outbreaks in the last three months.

It is important that acute care health facilities (ACHF) and long-term care facilities (LTCF) report all outbreaks and be prepared to institute infection control measures quickly. <u>Outbreaks, suspected or confirmed, should be reported</u> <u>immediately to San Mateo County Communicable Disease Control and CDPH Licensing & Certification</u> <u>Division</u>. Additionally, we strongly recommend that facilities submit specimens from suspected norovirus outbreaks for testing so that this new virus can continue to be tracked.

<u>How to report</u>: Monday through Friday, 8 am to 5 pm, call Communicable Disease Control, (650) 573-2346; after hours, weekends and holidays, call San Mateo County Dispatch, (650) 363-4981 and ask to speak to the on-call Health Officer.

<u>Submitting specimens</u>: Stool or vomitus specimens maybe submitted in a sterile container to San Mateo County Public Health Laboratory, 225 W. 37<sup>th</sup> Avenue, Rm. 113, San Mateo, CA 94403. Questions regarding collection, storage and transport may be directed to the Public Health Laboratory, (650) 573-2500.

#### **Categories of urgency levels:**

Health Alert: conveys the highest level of importance; warrants immediate action or attention. Health Advisory: provides important information for a specific incident or situation; may not require immediate action. Health Update: provides information regarding an incident or situation; unlikely to require immediate attention.
