On page 6, Section V, B contractor is asked to provide a statement that addresses: "Describe your service model and approach to addressing the service needs of the target population, your approach to working collaboratively with multi-agency partners, and the geographic area of the County, if applicable"

5. What is the term of the contract? There is no indication on the RFI.

The term of the agreement is July 1, 2017 through June 30, 2018, with the option to renew annually for an additional two years.
