It's a further walk but already designated as an ADA drop off zone for governmental buildings. A sign is already put up for loading and unloading.</li><li>2. Margaret Baggerly - A decision has been made to postpone the SMC Transportation Resources Showcase to 2026 due to a tight timeline and funding uncertainty. Looking at September of next year (2026) and some bigger venues. More updates to come in the future.</li></ol>
