- 1. Chair Michael Mau called the meeting to order at 3pm.
- 2. Note taking: Michael.

- 4. Agenda reviewed, no changes.
- 5. Prior meeting notes reviewed, no changes.

## 6. Member Reports:

Commissioner Leth - Vaccination clinic at Coastsiders senior center, only 100 doses but all were used.

Commissioner McMullin - Redi-wheels ridership still down due to the pandemic. Redi-wheels data did not include Redi-coast. PCC needs and is still recruiting new members. Meets 2<sup>nd</sup> Tuesday monthly, 1:30-3:00. Express lane project on Peninsula between RWC and SB was reported in PCC, and a discussion equity projects. Ongoing discussion with Kaiser rep. on vaccination transportation for Coastside members, but nothing new yet.

Commissioner Uhl - Reported that SamTrans offering free rides to vaccination sites (non drive thru).

Commissioner Mau - Based on similar action taken by the Got Wheels program, he recommended that the CaR program offer free rides to its senior members to vaccine sites (non drive thru), and the feedback was it should be implemented. Met with Pacifica's new Senior Services Manager who has a long history in senior services. Pacifica CAFE task force just met this same week, and will respond to the Ad-Hoc questionnaire. Also noted hearing at the COA general meeting the grant to CAFE for three more cities at a grant cost of approximately \$120,000, which might be enough to pay a full time staffer to be a full time coordinator for all age friendly cities.

- 7. New Business: Christina Ugaitafa announced that Jean Konger at SamTrans just retired. San Mateo County Transporation Authority advisory group to review Measure W and related activities, is looking for members. Also noted the SamTrans free rides but only to vaccine clinics (non drive thru).
- 8. Next meeting for TC will be in 2021 (normally 2<sup>nd</sup> Thursday from 3-4 p.m.). Due to the pandemic, meeting frequency will still fluctuate, but announcements will be by email. Meeting adjourned at about 4 pm.
