# **Public Hearing Purpose**

To provide the community (older adults, adults with disabilities, and caregivers) the opportunity to comment on the development and content of the Area Plan for Older Adults and Adults with Disabilities in San Mateo County



### Public Hearing Requirement

Required at least one time in each year of each Area Plan Cycle

Area Plan Cycle is usually four years: FY 2016-2020

Area Plan Update: FY 17-18



## What is the Area Plan?

- Reflects Area Agency on Aging (AAA) activities
- Involves older adults, their families, and caregivers
- Format and structure to identify needs and address concerns consistent with the Older Americans Act and the Older Californians Act to enable communities and AAAs to plan for future



### Why do we have an Area Plan?

- OAA- (1965) Prioritized older adults
- OCA- How OAA is administered in California
- AAA for San Mateo County- Aging and Adult Services
- Area Plan is requirement for the funding



### Area Plan Development

#### Needs Assessment Purpose

- Identify needs of target population
- Identify existing services/resources
- Identify existing constraints



### **Target Population**

- Older Adults in the Community
- Homebound
- Adults with Disabilities
- Caregivers
- Adults Living in Facilities (Different Survey-LTC Facility Survey)





#### **Community Assessment**

**Secondary Data** 

Needs assessment for current Area Plan conducted in fall/winter of 2015/2016



# Survey Results: Top 10 Issues

- Learning about services/benefits for older adults
- Remaining in home
- Financial security/Money to live on
- Understanding Medicare
- Dental Needs
- Accessing and enrolling for services
- Disaster preparedness
- Accidents in the home (falls)
- Affordable housing
- Dependence on others



### Area Plan Goals

- 1) Promote a community-based system of services that supports independence, socialization, and safety
- 2) Support options for increased mobility
- 3) Promote/support affordable and accessible housing options in San Mateo County
- 4) San Mateo County will be an age friendly community

- New Beginning Coalition (NBC)
- NBC Steering Committee
- Meetings quarterly: Next meeting on April 18<sup>th</sup>



## Area Plan Funding

- Older Americans Act programs
- Collaborative work (non-OAA program activities)



#### Older Americans Act Allocations FY 16-17

- IIIB Legal Assistance, ADC/ADHC, Transportation, Information and Assistance, Employment, Q system, PDAC- \$668,146
- IIIC Congregate Lunch \$562,874
- IIIC2 Home Delivered Meals \$903,425
- IIID Health Promotion \$40,321
- IIIE Family Caregiver Support \$273,419
- VIIB Elder Abuse Prevention \$9,814
- Senior Ombudsman Services- \$184,059
- Health Insurance Counseling & Advocacy Program (HICAP) - \$286,827 (grant from Administration for Community Living)



#### Title IIIB: Adequate Proportions Percentages

Establishes <u>minimum</u> percentage of 50% of Title IIIB federal funds for annual expenditures in:

- Access
- In-Home Services
- Legal Assistance



# Adequate Proportions Designations

- <u>Minimum</u> allocation is determined by the AAA through the planning process
- These percentages are based on needs assessment findings and resources available within the PSA

# **Proposed Adequate Proportions**

- Access- 20%
- In-Home Services- 25%
- Legal Assistance- 5%



#### Program Development & Coordination

AAAs are allowed to use a designated portion of program funding to support Program Development & Coordination (PDAC) activities that are not administrative duties related to OAA programs

Proposed: 2% (III B)



## **Program Development Description**

#### Activities:

- Establish a new service
- Expand or integrate existing services



# **Coordination Description**

Involve active participation of AAA staff

May include collaboration with non-OAA funded agencies & organizations to:

- Avoid duplication
- Improve services
- Resolve problems related to service delivery
- Address the service needs of the eligible service population


